## 2019 NON-RESIDENT REGISTRATION INSTRUCTIONS

Please be advised that depending on volume, processing may take up to 3-4 weeks between March and early May.

### DEFINITIONS FOR POOL MEMBERSHIP:

- **FAMILY:** Family membership shall be limited to up to two (2) adults, and all legally dependent children residing in the same home that are under the age of 23 (born on or after 5/25/96).
  - **AU PAIR:** Person providing child care in return for room and board. May be considered one of the two adults permitted on a Family membership. The au pair must purchase a single membership or use a guest pass if exceeding the two-adult limit per family membership.
- **SINGLE:** Single membership shall be available for:
  - a) Individuals not qualifying for a Family membership.
  - b) A single adult whose child or children are four years of age or younger as of 1<sup>st</sup> day of pool season.
  - c) A child who is at least 12 years of age as of the 1<sup>st</sup> day of pool season.
- **SENIOR:** Senior memberships are available for individuals age 65+. Proof of age required

**Drop-off:** During business hours M-F; 9am – 5pm; Sat. 9am – 12pm or in the drop box located on the side of the Conservancy office after hours.

Stickers will be sent via U.S. mail for registration forms requiring current 2019 stickers for existing I.D. cards that are not submitted in person.

### POOL MEMBERSHIP I.D. CARDS:

Pictures of children should be updated every three years; adult pictures should be updated if appearance has changed dramatically. **All pool members age of 5, as of the 1<sup>st</sup> day of pool season, must have a photo I.D. card with current photograph.**

If you are joining the pool for the first time, or your pictures need to be updated, in conjunction with completed pool registration form, please do one of the following:

- Submit one photo (front facing head shots) of each member who will be using the pool or whose photo needs to be updated. Photos must be individual and clearly identifiable. Write the name, phone number, and date of birth of each person legibly on the back of the photo. The person's face in the photo must not be larger than 1" x 1-1/4". **DO NOT** cut photos or attach the pictures to the form with staples.
- Submit photos via email to [PoolClerk@burkecentre.org](mailto:PoolClerk@burkecentre.org). Photos must be of a single individual and clearly identifiable (i.e. a description of clothing and/or hair color). Include the name, phone number, and date of birth of each person a photo is submitted for.

Until all necessary photos are received, membership registrations will not be fully processed, therefore, resulting in a delay in receiving photo I.D. cards and/or pool stickers.

### POOL GUEST RATES FOR NON-RESIDENTS

Guests age 4 and under enter free.

**SINGLE DAY GUEST PASS: \$5 per guest**

**10-VISIT GUEST PASS: \$40.00 (discounted rate)**

**\*NOTE:** Guest passes are available for sale only to current season pool members! Pool member must accompany and sign in all guests. Guest passes are limited to 30 visits per membership application and are non-refundable, non-transferable, and **valid for current pool season only**.

**Please plan ahead** – guest passes can only be purchased at the Conservancy office during business hours (M-F: 9 AM – 5 PM & Sat: 9 AM-Noon). When visiting the office to purchase guest passes, please have your current pool ID with you for membership verification.

### REPLACEMENT I.D. CARDS AND/OR STICKERS:

If your pool photo I.D. card(s) and/or sticker(s) are misplaced, **once they have been issued for the current pool season**, the cost for replacement is \$12.00 per card and/or sticker. NO REFUNDS will be given for replacement I.D. cards once they have been made. The maximum cost for families in need of replacement I.D. cards and/or stickers will be \$25.00.

### REFUNDS:

**PRIOR TO SEASON:** A 100% refund of membership fee will be granted if requested by 5 PM, May 22, 2019. All I.D. cards and/or stickers issued must be returned at time of request. THIS REQUEST MUST BE MADE IN WRITING TO: Burke Centre Conservancy, 6060 Burke Centre Parkway, Burke, VA 22015-3702, Attn: Community Services-Activities. **NOTE:** No refunds will be granted after May 22, 2019. Sorry, no exceptions.
